Health conditions for the implementation of hygiene services

Description the services: These are the procedures and processes implemented to maintain the health and environment of the facilities within the target level, including action plans, equipment and human materials necessary for the operation

The basic standards for hygiene.

- Obtaining a license for the activities of hygiene services.
- Obtaining accreditation from the Department of Health, Safety and Environment.
- Provide an integrated and approved action plan from the Department of HSE
- The activities carried out are in accordance with all local and federal laws and regulations on environmental conservation.
- The company must have an ISO certificate 14001 and 18001.
- Providing modern, specialized and adequate resources of equipment, technical staff and materials for cleaning and sterilization according to numbers and quantities that meet a high level of service
- Providing integrated and continuous training programs for employees
- The adoption of sterilization is an essential part of the cleaning process for the facilities that need it, which will be explained within the hygiene program.
- Provide employees with all necessary tools and personal protection and protection tools commensurate with the nature of their work.
- Provide employees with all the tools and equipment needed to enable them to perform their work professionally and effectively.
- Provide uniforms for technicians, supervisors, workers and observers and carry the company's logo.

Basic standards for waste transport and disposal waste

Description of service: Transport and disposal of public waste in healthy and environmentally safe ways.

- Obtaining a license for waste transportation services activities.
- Accreditation from the Department of Health, Safety and Environment
- The activities carried out are in accordance with all local and federal laws and regulations on environmental conservation.
- The company must have an ISO certificate 14001 and 18001.
- Providing modern, specialized and adequate resources of equipment, technical staff and materials for transporting and disposal waste and sterilization according to numbers and quantities that meet a high level of service
- Provide employees with all necessary tools and personal protection and protection tools commensurate with the nature of their work.
- Provide uniforms for technicians, supervisors, workers and observers and carry the company's logo.

Basic standards for hazardous waste transport services

Description of service: Transport and disposal of hazardous waste in healthy and environmentally safe ways.

- Obtaining a license for hazardous waste transportation services activities from government agencies.
- Obtain accreditation from the Department of Health, Safety and Environment for the activity.
- Obtaining accreditation for hazardous waste transport vehicles.
- The activities carried out are in accordance with all local and federal laws and regulations on environmental conservation.
- The company must have an ISO certificate 14001 and 18001.
