

Ajman Free Zone Referral Program Terms and Condition

1. Ajman free zone (AFZ) will run the AFZ Referral Program (the Program), subject to Terms and Conditions, which is available to individuals and Companies who meet the criteria set out in the Terms and Conditions which submit a Referral to AFZ (Assignee) for a new client to set up a *new* AFZ company.
2. The Program will commence in A2020 and will continue to be executed for an unlimited period of time unless expressly canceled by Ajman Free Zone (the Term).
3. In order to be eligible for the Program, a Referrer *must meet with the following criteria* :
 - (a) To be an individual having a valid Passport with minimum age of 21 years old or to be a company
 - (b) Not to be associated with a company which has a license allowing it to act as a corporate service provider or to carry out any activity that is specialized in setting up companies in AFZ;
 - (b) Not to be an employee of AFZ;
 - (C) *The new Company should* complete the registration stage for company setup within the AFZ, and pay all associated license fees, within the Term;
 - (d) To send a dedicated Sign Up link / form to the Assignee or refer it to the website of the Assignee "afz.ae";
 - (e) Not to be previously registered on the AFZ online portal or have initiated enquiries to set up a AFZ company previously, whether before or after the commencement of the Term;
 - (f) Not have been referred to AFZ by a third party previously, whether before or after the commencement of the Term.
4. For each referral meeting both the Assignee Criteria and the Assignor who made a Successful Referral, AFZ will credit the agreed amount as per the approved referral *commission* Scheme to the Assignor's company bank account.
5. The Program is offered at the discretion of AFZ and does not create legally binding obligations on AFZ.
6. AFZ shall have absolute discretion in its application of the program and the Terms and Conditions and there will be no right of *judicial recourse* to any decision made by AFZ in this regard.
7. AFZ may hold, void, restrict, cancel, withdraw, suspend, delay, review or amend the Program, without liability to any party whatsoever.

8. The Program and Terms and Conditions are governed by the laws which is applicable in the Emirate of Ajman and any dispute arising out of or in relation to the program and the Terms and Conditions will be subject to the exclusive jurisdiction of the *Dispute Committee in Ajman Free Zone*
9. *The disbursement of the Referral commission should be as per the following Scheme:*
